The media industry is transforming into a completely digitised world of experience. As a centre for digital moving images, D-Werft conducts research on the challenges this

transformation with its ever increasing amounts of data entails for the film and TV industry. The Humboldt Institute for Internet and Society is a part of the research alliance, which is funded by the German Federal Ministry of Education and Research. Our research activities focus especially on two questions: How is film and video consumption changing and what are the consequences for the industry concerning business model innovation? How do German copyright regulations influence the use of orphan film works and what kinds of legal provisions could enable a legal use of orphan works?

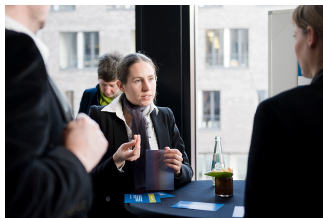

WORKSHOP: LEGAL LIMITS TO SURVEILLANCE OF INDIVIDUALS BY SECRET SERVICES



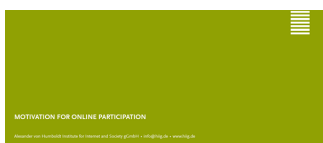
In the wake of the NSA revelations, doctoral researchers of the Alexander von Humboldt Institute for Internet and Society organised a series of expert workshops focusing on the activities of German intelligence agencies.

The initial workshop in February explored the secret surveillance practices. It provided an overview of the actions especially concerning legal provisions and their efficacy. A second workshop focused on the extraterritorial applicability of the fundamental rights of the German basic law as well as the respective rights of the European Convention on Human Rights. The Walter Hallstein Institute for European Constitutional Law and the stiftung neue verantwortung co-hosted the workshop.

motivation for online co-creation. The paper relates to the HIIG's joint research topic of online participation. In this context we are also carrying out a study in cooperation with TNS Infratest, to analyse the characteristics of using the Internet for both political participation and business collaboration. The study will be published within the following months.

CLOUD STRATEGY FOR CHILE

In an international workshop hosted by the Chilean government and co-organised by the Humboldt Institute for Internet and Society, experts from the public sector, academia, the industry and the civil society reflected upon a

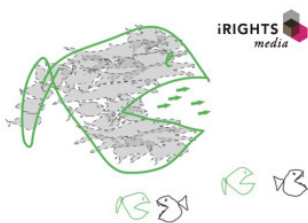


strategy that could leverage Chile to become a digital hub for cloud computing services in Latin America. The workshop inspired the government to establish a public-private advisory committee that would formulate specific recommendations. The study was submitted to the Chilean Minister of Economy

in March. HIIG researcher Osvaldo Saldías chaired the sub-committee on "Digital education for a digital hub".
